### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** First aid measures not required.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.  
**Eye contact:** Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.  
**Ingestion:** Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

#### Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After skin contact: Repeated or prolonged excessive exposure may cause irritation or dermatitis. After ingestion: May be fatal if swallowed and enters airways. Nausea and possible vomiting may occur. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation.

#### Indication of any immediate medical attention and special treatment needed
